1. A memorial stone with or without plinth not exceeding 1m in height, 60cm in width and 30cm thickness.	171.00
2. A memorial vase only, preferably square or rectangular in shape, to an overall dimension not exceeding 30cm in height and 25 x 25cm.	42.00
3. Additional Inscription to a monument.	45.00
4. Simple hardwood wooden cross not exceeding 75cm x 45cm	24.00
