NB -

If an applicant for a Club Gaming Permit or Club Machine Permit holds a Club Premises Certificate they may apply as fast track (ie it has already been established when they applied for Club Premises Certificate that they are a bona fide Club). The application is fee is £100 and annual fee is £50 however the permit will continue to run whilst the Club Premises Certificate is in force (i.e. there is no renewal).

If an applicant for Club Gaming Permit or Club Machine Permit does not hold a Club Premises Certificate but holds a Part 1 or Part 2 registration they are not fast track however they have reduced application fee of £100.
