

## **Role:**

The Tenant Action Group plays a vital role in helping Stroud District Council improve the quality of services provided to residents. The TAG Group will consist of a group of residents who act as a critical friend to influence the shape of SDC's housing services through independent investigation. Their research involves spending time looking at information and evidence to help make suggestions for improving services. Tenant Scrutiny is independent but works with support from SDC staff to decide what to investigate, where to find the evidence they need and to present their findings to the Tenant Oversight Panel (TOP).

## **What does this involve?**

- Regular attendance at monthly meetings
- The opportunity to attend national tenant scrutiny conferences
- Working with other members of the panel to investigate an area of the housing service which can include any of the following:
  - Reading national and local policies relevant to the topic under investigation
  - Carrying out tenant and leaseholder surveys\*
  - Interviewing staff\*
  - The opportunity to shadow staff\*
  - Recommending ways to improve the service under investigation
  - Contributing to a report on Tenant Scrutiny investigative findings and recommendations for improvement.
  - Participating in presenting Tenant Scrutiny investigation results and recommendations to senior managers, councillors and TOP

## **How much time does it take?**

The Scrutiny Working Group will meet to decide an area for investigation and decide the next steps. Members of the Scrutiny Working Group will

divide up investigative work among themselves at the start of an investigation according to their individual areas of interest, expertise and availability. The Working group will then meet monthly to discuss their findings. During an investigation some group members may require an extra meeting between the scheduled monthly meetings or undertake an external visit if the Working Group decide this is needed.

### **What we are looking for:**

- A desire to act on behalf of residents to improve services for everyone who lives in an SDC property
- A desire to work as part of a team and contribute to group discussions
- The ability to understand (willingness to learn) performance and policy documents and give a view on them to a group of people
- Have good listening skills and be prepared to listen to other points of view
- Commit to the time needed for monthly meetings with additional time needed for reading outside of these meetings.
- Willingness to undertake induction. This will require a greater time commitment initially.
- Basic IT skills, including communication via email.
- The ability to report observations and suggest feedback.
- Access to the internet

### **What's in it for you:**

- Help us to improve the Housing Service for residents.
- Gaining a good understanding of social housing, locally and nationally - it's about people, it's complex and extremely interesting
- Develop your skills.
- Gain knowledge (and qualifications) through training sessions.
- Help us ensure we are transparent and accountable to residents
- The satisfaction of knowing that you have a place at the 'top table' and play a key part in influencing and shaping a better housing service for SDC residents.

### **Our commitment to you:**

**Level of commitment:**

- Able to dedicate 2 hours per monthly meeting. Approximately 2 hours per month for reading and recording observations per service review.
