## STROUD DISTRICT COUNCIL (OFF STREET PARKING PLACES) (CONSOLIDATION) ORDER 2010 (AS AMENDED) VARIATION ORDER 2021

WHEREAS the Stroud District Council (Off-Street Parking Places) (Consolidation) Order 2010 ("the 2010 Order") was made by the Council for the purposes of consolidating previous off-street parking orders;

AND WHEREAS the 2010 Order has been amended by variation orders dated 10<sup>th</sup> August 2010, 11<sup>th</sup> January 2011, 28<sup>th</sup> April 2011, 16<sup>th</sup> April 2013 and 18<sup>th</sup> March 2019 and the parking charges referred to in the 2010 Order were amended by notices dated 28<sup>th</sup> September 2017, 3<sup>rd</sup> March 2020 and 11<sup>th</sup> March 2021;

NOW THE STROUD DISTRICT COUNCIL in the County of Gloucester in the exercise of its powers under sections 32 and 35 and Schedule 9 Part IV of the Road Traffic Regulation Act 1984 (hereinafter referred to as "the Act") and of all other powers enabling it in that regard and with the consent of the Gloucestershire County Council pursuant to Section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Schedule 9 Part III paragraph 20(1) of the Act hereby makes the following Order:

1. This Order may be cited as the Stroud District Council (Off Street Parking Places) (Consolidation) Order 2010 (as amended) Variation Order 2021.
2. The Order shall have effect so as to vary the 2010 Order as set out in the Schedule to this Order.
3. This Order shall come into operation on 7 March 2022.

## SCHEDULE

### Variations to the 2010 Order

1. The list of parking places on the cover page to Schedule 1 *"Pay and Display (Charging) Car Parks Stroud District"* shall be updated as follows:
  - i. *"Multi Storey London Road Levels 1 and 1A, 5 & 5A"* shall be renamed *"Multi Storey London Road (All Levels)"*;
  - ii. *"Multi Storey London Road Levels 2 to 4A"* shall be deleted and not replaced;  
and
  - iii. *"London Road"* shall be renamed *"London Road Surface Car Park"*.
2. The table for Stroud - Long Stay at Schedule 1 *"Use of Parking Places and Scale of Charges"* table for shall be updated as follows:
  - i. *"London Road"* shall be renamed *"London Road Surface Car Park"*;
  - ii. *"Multi Storey London Road Levels 1 and 1A, 5 & 5A"* shall be renamed *"Multi Storey London Road (All Levels)"*; and
  - iii. the Hours of Operation for *"Multi Storey London Road (All Levels)"* shall be varied by deleting the words *"opening between 07:00am – 6:30pm"* and substituting therefor the words *"opening between 06:00am – 9:00pm"*.
3. In the table for Stroud - Short Stay at Schedule 1 *"Use of Parking Places and Scale of Charges"*, the entries for *"Multi Storey London Road Levels 2 to 4A"* shall be deleted in their entirety and not replaced.
4. In the table for Stroud - Short Stay at Schedule 1 *"Use of Parking Places and Scale of Charges"*, the Maximum Stay Length of *"2 hours"* for Church Street shall be deleted and replaced with *"3 hours"*.

5. Table 1: "*Times and Charges*" of Schedule 6 of the 2010 Order shall be varied so that:

- i. "*London Road*" shall be renamed "*London Road Surface Car Park*";
- ii. "*Multi-Storey Levels 1, 1A 5 & 5A*" shall be renamed "*Multi-Storey London Road (All Levels)*";
- iii. the Charging Times for "*Multi Storey London Road (All Levels)*" shall be updated by deleting the words "*opening between 07:00am – 6:30pm*" and substituting therefor the words "*opening between 06:00am – 9:00pm*";
- iv. the Charging Times for "*Multi Storey London Road (All Levels)*" shall be updated by deleting the words "*All days excluding Sundays and Bank Holidays*" and substituting therefor the words "*Monday to Saturday inclusive, Car Park (All levels) closed all day on Sundays and Bank Holidays except for pre-arranged events*";
- v. the Scale of Season Ticket Charges for "*Multi-Storey London Road (All Levels)*" shall be updated by inserting: "*Weekly: £15.00*" and "*Fortnightly £29.00*";
- vi. the Scale of Season Ticket Charges for "*London Road Surface Car Park*" shall be updated by inserting: "*Weekly: £15.00*" and "*Fortnightly £29.00*";
- vii. the Scale of Charges for "*Church Street*" shall be updated by inserting "*£4.00 up to 3hrs*";
- viii. the entries for "*Multi-Storey Levels 2 to 4A*" shall be deleted in their entirety and not replaced; and
- ix. the reference to "*6pm*" under Charging Times for "*London Road Surface Car Park*" is deleted and replaced with "*3pm*".

6. The Plans of the Car Parks within the Appendices shall be updated as follows:

- i. Appendix 1.4 "*London Road Car Park*" shall be renamed "*London Road Surface Car Park*";

- ii. Appendix 1.6 "*Multi Storey, London Road – Levels 1-1A & 5 – 5A*" shall be renamed "*Multi Storey London Road (All Levels)*"; and
- iii. Appendix 1.9 "*Multi-Storey, London Road – Levels 2 - 4A*" shall be deleted and not replaced.
