

Local Spend and Suppliers

Following a query raised at Council in response to the recommendation from the Committee to Council at its meeting in July, this Information Sheet provides an outline of Council contracts entered into with local suppliers. The Council spend analysis undertaken for 2014/15, 2015/16 and 2016/17 is set out below; following an outline as to the procedures applied when outsourcing goods, services and works

The information includes:

- Spend in groupings to reflect our procurement thresholds.
- Overall percentage of spend in Gloucestershire.
- Percentage of Gloucestershire suppliers.
- Top Ten GL postcode Suppliers for each year.

The Council has defined a local supplier as an 'organisation with a GL postcode'. For spend under £5,000 Officers must be able to demonstrate value for money by comparing prices from different suppliers or contractors. It is recommended that at least three suppliers or contractors are approached by telephone or e-mail and prices obtained.

Between £5,000 and £24,999 Officers are required to use the South West Procurement Portal. Using a Quick Quote through the Portal, Officers can request quotes from up to 8 suppliers, 3 of these will be local suppliers (GL postcode) randomly generated. Two of these will be non local suppliers also randomly generated. The final 3 are suppliers of the Officers choice.

For spend between £25,000 and £74,999 (previously up to £49,999) Officers are required to use the Procurement Portal. Using a 'Request for Quotes' open procedure.

Between £75,000 and EU thresholds*. Officers are required to use the Procurement Portal to publish an Invitation to Tender (ITT). For Spend over EU threshold*, again officers are required to use the Procurement Portal to publish an Invitation to Tender (ITT) ensuring legislative notices and timescales are published and adhered to.

Please note: All contracts over £25,000 are published through the portal as an open procedure; all suppliers registered under the relevant (CPV) code will be notified of the opportunity. All contracts with an estimated value of £25,000 and over also need to be published on the government's website contacts finder (www.gov.uk/contracts-finder)

*EU Thresholds £164,176 for Supplies and Services and £4,104,394 for Works.

If the estimated contract value is below current EU thresholds but is estimated to be within 5% (Supplies & Services) or 10% (Works) of the EU thresholds then EU procedures should be followed.
