

**STROUD DISTRICT COUNCIL (OFF STREET PARKING PLACES)
(CONSOLIDATION) ORDER 2010 (AS AMENDED) VARIATION ORDER no. 2
2026**

WHEREAS the Stroud District Council (Off-Street Parking Places) (Consolidation) Order 2010 (“the 2010 Order”) was made by the Council for the purposes of consolidating previous off street parking orders;

AND WHEREAS the 2010 Order has been amended by variation orders dated 10 August 2010, 11 January 2011, 28 April 2011, 16 April 2013, 18 March 2019, 7 March 2022, 18 October 2022, 16 February 2024, 2 April 2024, 29 August 2024, 31 March 2025 17 April 2025 and 6 February 2026 the parking charges referred to in the 2010 Order were amended by notices dated 28th September 2017, 3rd March 2020, 11th March 2021, 11th March 2022, 19th March 2024 and 12th March 2025.

NOW STROUD DISTRICT COUNCIL in the County of Gloucester in the exercise of its powers under sections 32 and 35 and Schedule 9 Part IV of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) and of all other powers enabling it in that regard and with the consent of the Gloucestershire County Council pursuant to Section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Schedule 9 Part III paragraph 20(1) of the Act hereby makes the following Order:

1. This Order may be cited as the Stroud District Council (Off Street Parking Places) (Consolidation) Order 2010 (as amended) Variation Order No 2 2026
2. The Order shall have effect so as to vary the 2010 Order as set out in the Schedule to this Order.
3. This Order shall come into operation on 17 day of March 2026

SCHEDULE

Variations to the 2010 Order

1. Schedule 1 – Pay and Display (Charging) Car Parks Stroud District Council – Use of Parking places and Scale of Charges shall be varied as follows:

- (i) In the list of car parks described as “Short Stay” on page 1, references to Ebley Wharf car park shall be deleted.
- (ii) In the list of car parks described as “Long Stay” on page 1, “Ebley Wharf car park” shall be inserted
- (iii) In the list of Parking Places and Scale of Charges – Stroud – Short Stay on page 4 of Schedule 1, all references to Ebley Wharf car park shall be deleted
- (iv) In the list of car parks described as “Long Stay on page 3 of schedule 1 the following shall be inserted:
