<p>Brief Description: Like Eastcombe the previous year, we have installed cricket nets at the western boundary of the cricket pitch; these are 8m tall and we have installed 11. The Parish Council purchased the nets and posts, and the cricket team installed them using members of the team to help. This has improved the relationship with the neighbours and ensured that cricket can continue to be played on the ground.</p> <p>Date Project Completed: May 2024</p>

Yes, the number of balls going into neighbouring properties has decreased and the relationship with the neighbours has improved

Project Name: Widening of entrance to Eastcombe Recreation Ground

Project Location: Eastcombe Recreation Ground, Middle Hill, Eastcombe, GL6 7DY

Brief Description: One of the entrances (a stone wall) was widened and a new concrete ramp was extended to enable a disabled parishioner to enter the ground to walk her dogs. The improvement has also benefitted other

parishioners with limited mobility on motorised scooters and those with pushchairs who wish to use the new junior playground

Date Project Completed: July 2024

Has the project been successful? *Please include any pictures of the project you may have*

Yes – the parishioner who requested the improvement has written to thank us and councillors have seen multiple other users who no longer have to lift pushchairs over the wall. Footfall within the ground has increased.

"I have been to the recreation ground over the weekend with Rosie and Poppy and I am delighted to say the entrance is great. Its nice and wide I turned left and went down the concrete ramp and drove all the way round the field and came out the same way. I was able to maneuver the scooter to avoid the metal barrier."
