

**STROUD DISTRICT COUNCIL (OFF STREET PARKING PLACES)  
(CONSOLIDATION) ORDER 2010 (AS AMENDED) VARIATION ORDER**

**No. 1, 2026**

**WHEREAS** the Stroud District Council (Off-Street Parking Places) (Consolidation) Order 2010 (“the 2010 Order”) was made by the Council for the purposes of consolidating previous off street parking orders;

**AND WHEREAS** the 2010 Order has been amended by variation orders dated 10 August 2010, 11 January 2011, 28 April 2011, 16 April 2013, 18 March 2019, 7 March 2022, 18 October 2022, 16 February 2024, 2 April 2024, 29 August 2024, 31 March 2025 and 17 April 2025 the parking charges referred to in the 2010 Order were amended by notices dated 28 September 2017, 3 March 2020, 11 March 2021, 1<sup>st</sup> April 2022, 3<sup>rd</sup> April 2023, 15<sup>th</sup> April 2024 and 1<sup>st</sup> April 2025.

**NOW STROUD DISTRICT COUNCIL** in the County of Gloucester in the exercise of its powers under sections 32 and 35 and Schedule 9 Part IV of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act”) and of all other powers enabling it in that regard and with the consent of the Gloucestershire County Council pursuant to Section 39(3) of the Act and after consultation with the Chief Officer of Police in accordance with Schedule 9 Part III paragraph 20(1) of the Act hereby makes the following Order:

1. This Order may be cited as the Stroud District Council (Off Street Parking Places) (Consolidation) Order 2010 (as amended) Variation Order No 1, 2026
2. The Order shall have effect so as to vary the 2010 Order as set out in the Schedule to this Order.
3. This Order shall come into operation on day of 3 February 2026.

## **SCHEDULE**

### **Variations to the 2010 Order**

**1. The interpretation clause shall be amended as follows:**

- (i) In the definition of **“Pay and Display Ticket”** the following wording shall be inserted between “payment of charge” and “and valid for a parking period”:

**“or issued at zero monetary value”**

- (ii) In the definition of **“Ticket machine”** the following wording shall be inserted between “payment of the parking charge” and “and the time by which the parking period”:

**“or issued at zero monetary value”**

**2. In Part III Charges for Parking, a new Clause 13(a) shall be inserted as follows:**

“For the long stay area of Stonehouse Car park as identified by the plan at Appendix 1.2, a driver must obtain a zero-value Pay and Display ticket from the ticket machine and display it clearly on the dashboard or windscreen of the vehicle throughout the duration of the parking. For the avoidance of any doubt, indication of use of the concessionary free period of parking at Stonehouse car park long stay area can only be authenticated by the display of a ticket issued at zero monetary value.”

3. In **Part III Charges for Parking** the following wording shall be inserted into Clause 14. (i) after the wording “payment of the charge” and before the wording “in the relevant position”:

**“or obtained at zero value”**

4. In **Part III Charges for Parking** the following wording shall be inserted into Clause 14 (ii) after the wording “is purchased” and before the wording “and displayed”:

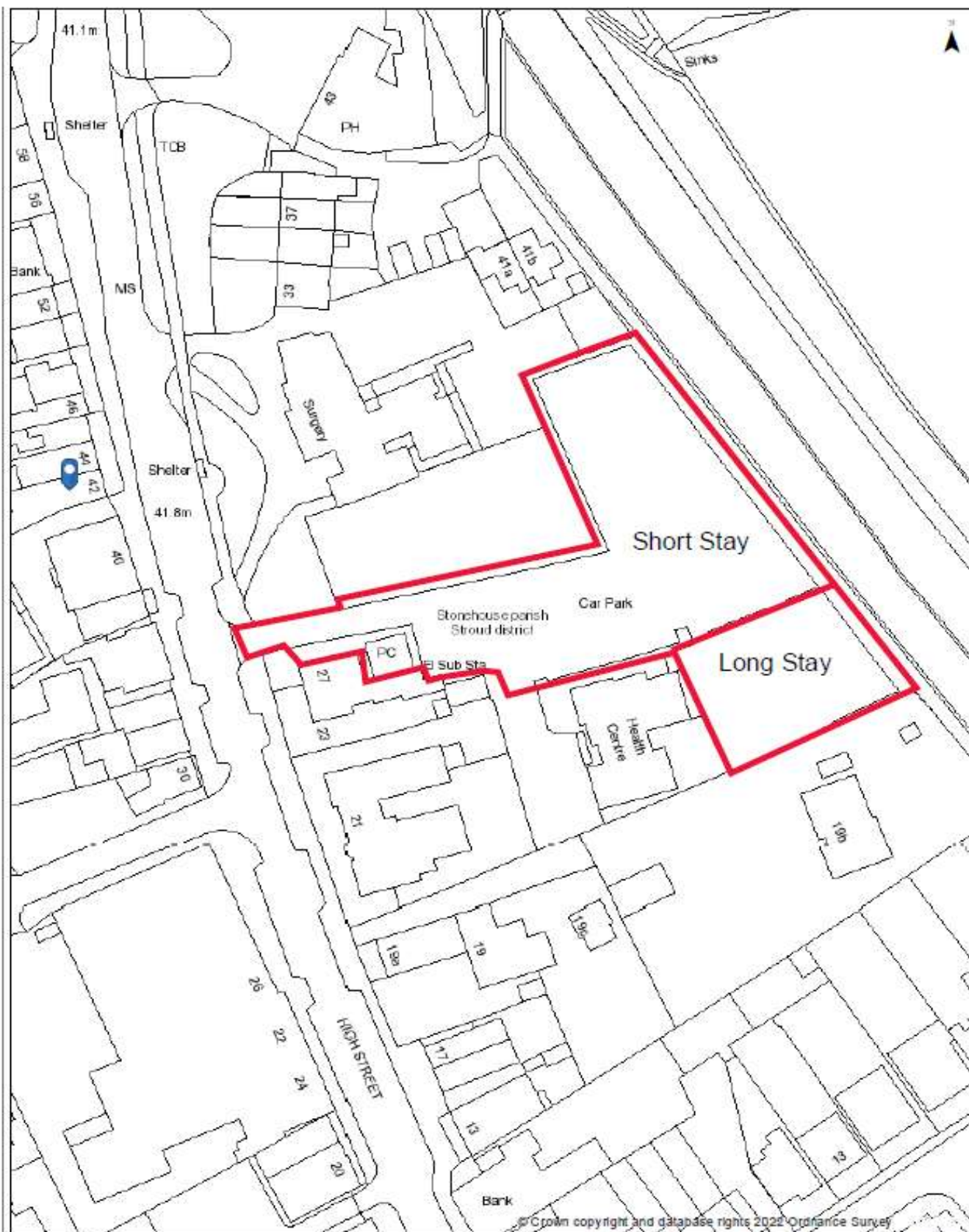
**“or obtained at zero value”**

5. In **Part III Charges for Parking, Clause 18 – No ticket displayed** – the following wording shall be inserted after “it shall be deemed that the charge has not been paid”:

**“or that the concessionary free period has not been bought into use”**

6. **Schedule 3A Column 2** of the table for the Stonehouse (long stay) area of the car park the wording of "23 hours" maximum stay shall be deleted and replaced with "9 hours" maximum stay
7. **Schedule 3A Column 4** of the table for the Stonehouse (short stay) area of the car park the wording "All hours" shall be deleted and replaced with "8 a.m. – 6 p.m." as the Hours of operation
