We wish to extend our premises licence to include the use of our ground floor undercroft. The undercroft is a partially open enclosure and forms the ground floor of Minchinhampton Market House. It provides a unique historic, intimate community space.

We wish to remove the condition relating to maximum number of persons from the licence. The occupancy/maximum numbers of persons will be compliant with the Market House fire risk assessment, which determines the safe number for occupancy in terms of fire safety and means of escape from the premises.

The proposed variation is in line with that currently permitted on the Market House's licence and the hours below pertain to the undercroft only. The hours for the hall remain unchanged to the current licence.

Minchinhampton Market House is run by volunteer Trustees as a Charitable Incorporated Organisation (CIO) with registered charity number 1180035.

The Trustees will endeavour to provide the additional steps below (b, c, d and e) to promote adequate licencing objective to support this variation to the current licence.

b) The prevention of crime and disorder

- Enhanced staff training on conflict management, responsible alcohol retailing, and refusal procedures.
- Use of a refusals and incident log, reviewed regularly by management.
- CCTV coverage maintained and monitored, with recordings retained in line with police guidance and made available upon request.

c) Public safety

- Regular risk assessments, particularly in relation to peak trading times affected by the variation.
- Increased management presence during busy periods.
- Ongoing staff training on emergency procedures, first aid awareness, and safe capacity management.
- Maintenance of clear access/egress routes and regular checks of safety equipment.

d) The prevention of public nuisance

- Active management of external areas, including monitoring noise levels and discouraging loitering.
- Waste and bottle disposal restricted to agreed hours to minimise disturbance.
- Liaison with local residents and prompt response to any complaints.

e) The protection of children from harm

- Robust age-verification policy (Challenge 25), with regular refresher training for all staff.
- Prominent display of age-restriction signage at events.
- Maintenance of a refusals register specifically for underage sales attempts.
- Controls to ensure children are not exposed to inappropriate activities or content.

Notes for Guidance

This application cannot be used to vary the licence so as to extend the period for which the licence has effect or to vary substantially the premises to which it relates.  - Boxing or Wrestling Entertainment: no licence is required for a contest, exhibition or display of Greco-Roman wrestling, or freestyle wrestling between 08.00 and 23.00 on any day, provided that the audience does not exceed 1000. Combined fighting sports – defined as a contest, exhibition or display which combines boxing or wrestling with one or more martial arts – are licensable as a boxing or wrestling entertainment rather than an indoor sporting event.
 - Live music: no licence permission is required for:
 - a performance of unamplified live music between 08.00 and 23.00 on any day, on any premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - a performance of amplified live music between 08.00 and 23.00 on any day, in a workplace that is not licensed to sell alcohol on those premises, provided that the audience does not exceed 500.

- a performance of amplified live music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - a performance of amplified live music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school or (iii) the health care provider for the hospital.
 - Recorded Music: no licence permission is required for:
 - any playing of recorded music between 08.00 and 23.00 on any day on premises authorised to sell alcohol for consumption on those premises, provided that the audience does not exceed 500.
 - any playing of recorded music between 08.00 and 23.00 on any day, in a church hall, village hall, community hall, or other similar community premises, that is not licensed by a premises licence to sell alcohol, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance from a person who is responsible for the premises.
 - any playing of recorded music between 08.00 and 23.00 on any day, at the non-residential premises of (i) a local authority, or (ii) a school, or (iii) a hospital, provided that (a) the audience does not exceed 500, and (b) the organiser gets consent for the performance on the relevant premises from: (i) the local authority concerned, or (ii) the school proprietor or (iii) the health care provider for the hospital.
 - Dance: no licence is required for performances between 08.00 and 23.00 on any day, provided that the audience does not exceed 500. However, a performance which amounts to adult entertainment remains licensable.
 - Cross activity exemptions: no licence is required between 08.00 and 23.00 on any day, with no limit on audience size for:
 - any entertainment taking place on the premises of the local authority where the entertainment is provided by or on behalf of the local authority;
 - any entertainment taking place on the hospital premises of the health care provider where the entertainment is provided by or on behalf of the health care provider;
 - any entertainment taking place on the premises of the school where the entertainment is provided by or on behalf of the school proprietor; and
 - any entertainment (excluding films and a boxing or wrestling entertainment) taking place at a travelling circus, provided that (a) it takes place within a moveable structure that accommodates the audience, and (b) that the travelling circus has not been located on the same site for more than 28 consecutive days.
