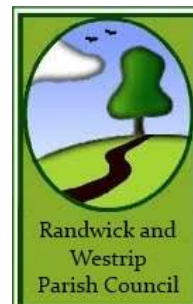

### Community Infrastructure Project 2:

**Project name and location:** Randwick Conservation Area Review.

**Brief description of works undertaken:** The parish council engaged consultants to carry out a review of the Randwick Conservation area, which was designated by Stroud District Council in 1990 but had not been reviewed since then, nor adopted by the Planning authority (Stroud District Council).

**Date Project Completed:** The appraisal was completed by October 31<sup>st</sup> 2022 and submitted to Stroud District Council in December 2022 but to date (August 2023) Stroud District Council Environment Committee has not found time to consider the document and approve it for public consultation.

**Has the project been successful? How?** The review was useful and engaged parishioners but success will depend upon SDC carrying out its part of the process. The parish council's intention was that the Conservation Area Statement would be adopted as Supplementary Planning Advice and help preserve the character of Randwick when planning applications are considered.
