Members will draft a quarterly report to be presented to the Housing Oversight Board meeting.

What does this involve?

- Monthly meetings.
- Working with other members to make recommendations on the housing service.
- Reviewing documentation from other groups' findings such as Scrutiny, Mystery Shopping and ASB Working Group.
- Forming a report for the Housing Oversight Board.
- Attending the Housing Oversight Board meetings to voice the findings of other groups.
- Sitting on the Housing Oversight Board.

How much commitment is needed?

- Able to dedicate approximately 2 hours per month.
- Able to dedicate approximately 1 hour 30 minutes on a weekday afternoon quarterly for the Housing Oversight Board meetings.
