These premises have successfully traded since 2017 offering a range of wines produced from their own vineyards, as well as wine tastings and vineyard tours, under premises licence 25/00870/LAPRVD.

This application seeks to:

Slightly increase the permitted hours (currently 11:00–20:00) to 10:00–21:30.

And

Extend the area covered by the existing licence to include the barn located at the rear of the Tasting Room. This space will be used to enhance the tasting experience by providing a more immersive and informative environment for visitors.

The barn will feature designated tasting stations positioned throughout the room, allowing guests to sample a range of wines in a relaxed and engaging setting. In addition, the space will include information boards and digital screens presenting content on viticultural and winemaking practices, as well as the geology and terroir of the region.

We believe this extension will significantly enhance the overall visitor experience while remaining fully compliant with all existing licensing conditions and obligations.


